Chairman's Report;

January 2018; Files late. DFAS reported errors creating the Air & Army Traditional and the AGR Army files.

February 2018; Communication with DFAS (LTC Dennis Baltimore) pertaining to the DD2558 and the Fed ID # vs SSN.

March 2018; AFBA submits Change of Administrator form for NGANJ

March 2018; Meeting set with DFAS on April 10th, 2018.

March 2018; NGAA inquires about password. Situation resolved.

April 2018; Retired pay issue with NGANC. Issue resolved.

April 2018; PDCB meets with DFAS. Report attached.

May 2018; PDCB Administrator reports issues with the transfer of retired pay files. Same issue occurred in November 2017. BG (Ret) Maria Kelly communicates with DFAS to assist the PDCB Administrator. The PDCB Administrator continued communication DFAS and corrects issue in June.

June 2018; GGIT inquires on their Change of Address for retirees.

August 2018; BG (Ret) Maria Kelly communicates with TSgt Breanna Oswalt (NGB) whom is working on IPPS-A. TSgt Breanna Oswalt had numerous questions on SSLI which BG (Ret) Maria Kelly responded.

August 2018; PDCB Administrator informs Chair that MA & VT have issues with retired pay.

September 2018; AFBA requests that Danny Sarco be added to distribution list.

September 2018; Chairman informs the PDCB the importance of getting ahead of the IPPS-A and requests BG (Ret) Maria Kelly work the ANG and BG (Ret) Ted Shuey work the ARNG on this new personnel program.

September 2018; AFBA inquires to maximum SSLI payroll deduction per month - \$100.

September 2018; PDCB Administrator informs Chair the Retired Files will be late.

October 2018; BG (Ret) Kelly obtains the primary contacts at DoD for IPPS-A. BG (Ret) Shuey follows up.

October 2018; AFBA informs Chair that "Associations received incorrect deposit amounts for September Air payments. Instead, of it being based on the September files, DFAS sent the exact same amount as the August Air payment". PDCB Administrator researches the issue with DFAS. Col (Ret) Tim Marlar notifies the associations of this issue and the resolve.

October 2018; AFBA submits Change of Administrator form for NGASD

October 2018; NGANJ requests copy of their MOA.


