#### Registration

Please ensure your registration is completed online or returned to <a href="mailto:mariakellyllc@gmail.com">mariakellyllc@gmail.com</a> by December 31, 2025. Please note that your association or company must first be a member to register for the conference. State association annual membership is \$300.00 and covers the membership of four named individuals. The conference registration fee for state association members is \$180.00 registration fee per person attending. Corporate annual membership is \$200 per company and covers membership for two named individuals. The conference registration fee is \$200 per person with an early bird rate of \$180 per person if paid for by COB on NGAUS Industry Day (December 9<sup>th</sup>). Additional individual memberships by both state associations and corporate partners are available for purchase once the allotted number of memberships are filled.

State associations are encouraged to bring elected officers to participate in collaborative sessions. Additionally, enlisted association Executive Directors can attend as a guest if the state association chooses to list them as one of their named members.
